

TrueStake (TSTK)

Token Sale Agreement, Terms, Digital Participation & Risk Disclosure

This document establishes the terms of participation in acquiring TrueStake (TSTK) tokens during Round 1 of the public sale. Confirmation of this document is mandatory to gain access to token purchase. The TrueStake project is owned by a legal entity registered in the Republic of Cyprus. TrueStake tokens are digital units of economic participation in the project.

Economic Nature of the Token

Digital Asset

TSTK is a digital asset reflecting a share of economic participation in the project.

Capitalization

50,000,000 TSTK = 100% digital capitalization of the project.

Round 1 Share

5,000,000 TSTK represent 10% digital participation.

The digital share reflects investor participation in the project's value and corresponds to a proportional economic share. TrueStake tokens are not securities but function as digital participation shares in accordance with international Web3 practices. Each token represents 1 / 50,000,000 of the digital participation share.

Token Structure

Total Issuance

100,000,000 TSTK

In circulation (Round 1 capitalization): 50,000,000 TSTK
Frozen tokens: 50,000,000 TSTK

Frozen tokens:

- stored on a separate public wallet
- do not participate in current digital capitalization

- do not affect the Round 1 share
- designated for future project rounds

Token Purchase Process

Send USDT
Investor sends USDT to the official project address

Complete form
Investor fills out the registration form on the website

Confirmation
Project confirms receipt of funds

Token transfer
Project sends TrueStake tokens to the specified address

Blockchain receipt
Investor receives transaction confirmation on the blockchain

Token Sale Agreement

Parties

The TrueStake project and the investor acquiring tokens

Subject

Transfer of TrueStake digital tokens to the investor in exchange for USDT payment in accordance with Round 1 terms

Payment terms

Payment is made in USDT to the official project address. Tokens are transferred only after confirmation of funds received

Token transfer

Transfer is executed on the TON network. The blockchain record is the final confirmation. No refunds are available after token transfer

Investor rights

The investor receives a digital share of economic participation in the project, expressed by the quantity of TrueStake tokens

Project obligations

The project commits to correctly transfer tokens and maintain distribution records

Important limitations

Tokens are not securities

Tokens do not guarantee profitability

The project may modify its development strategy

Risk Disclosure

The investor confirms understanding of the following risks.

Token price may fluctuate

Possible loss of invested funds

Technological risks

Loss of wallet access

Address input errors

Network delays or failures

Privacy & Data Protection

Data collection
The project collects only necessary data:

- email address
- TON wallet address

Data is used exclusively for transaction confirmation and is not shared with third parties. Privacy and security are a project priority.

Secure storage
All data is encrypted and protected

No third parties
Information is never shared externally

Transaction-only usage
Data is used solely for transaction confirmation
